

are sovereign. The Tenth Amendment affirms the principle of popular sovereignty – that "We the People" are in charge and hold ultimate authority.



THE VIRGINIA PLAN

During the Constitutional Convention, the founders considered the "Virginia Plan." This would have given Congress a general legislative power and a veto over state laws, among other things. The plan was defeated. What does this mean? The founders considered the kind of system we see in action today - and they rejected it.

RULE OF CONSTRUCTION

In legal terms, the 10th Amendment is known as a "rule of construction." It tells us how to view the entire constitution – that the People of the Several States created the federal government to be their agent for certain enumerated purposes only.

DECISIONS MADE CLOSER TO HOME

When states and local communities take the lead on policy, the people are that much closer to the policy makers, and policy makers are that much more accountable to the people. Few Americans have spoken with their president; many have spoken with their mayor.

LIMITED POWER

From their own experience, the Founders and Ratifiers learned that a government without limits is a tyranny. That's why they gave us a written Constitution, which clearly spelled out what the federal government is authorized to do.

DELEGATED POWERS

The Tenth Amendment defines the total scope of federal power as being that which has been delegated by the people of the several states to the federal government, and nothing more. The rest is to be handled by the state governments, or locally, by the people themselves.
