

NULLIFICATION

When a state 'nullifies' a federal law, it is proclaiming that the law in question is void and inoperative, or 'non-effective,' within the boundaries of that state; or, in other words, not a law as far as the state is concerned. To effectively nullify a federal law requires state action to prevent federal enforcement of that law within the state.
